

## American Legion Department of Wisconsin 8<sup>th</sup> District Fall Conference

## Fall 2017 Conference Minutes - November 21, 2017 Post 139 – Coloma, WI

- 1. District Commander Ron Fregien called the meeting to order at 0900 hours. The colors were posted and all present rendered a hand salute. The Chaplain gave an opening prayer. The POW/MIA flag was placed on the empty chair and Resolution 228 was read. Legionnaires then recited the Pledge of Allegiance and the Preamble to the Constitution of the American Legion.
- 2. Commander Fregien declared the meeting open and invited Waushara County Commander Wickersheim to address the Legionnaires. Commander Wickersheim welcomed everyone to Post 139 and wished them an enjoyable and successful conference. Post 139 Commander Burt also welcomed everyone to Post 239.
